MYTHS AND LITTLE KNOWN FACTS

CH 380 AGREEMENTS

- Myth: Incentives are done behind closed doors
 - Austin received a perfect score for Transparency of Economic Agreements by Good Jobs First (Washington, DC)
- Myth: Money for incentives could be used for parks, public safety, libraries, and other similar purposes
 - If a project doesn't locate in Austin, there is no money from the project
- 21 agreements executed since 2003; 2 Per Year (Avg)
- All agreements are performance-based, no clawbacks necessary
- Only cash positive proposals are brought forward

MYTHS AND LITTLE KNOWN FACTS

CH 380 AGREEMENTS

- Myth: Companies come to the City asking for incentives
 - Through Opportunity Austin, the City markets itself to businesses in targeted industry sectors that want to locate or expand in Austin.
- The City negotiates with the profit from each project
- Evaluation Matrix helps select companies that embrace
 Austin's core community values including, but not limited to:
 - Extend benefits to domestic partners and their dependents
 - Provide employees training and opportunities for advancement
 - Good wages and employee diversity in hiring and promotion

LOCAL IMPACT: COMPANIES MAKING A DIFFERENCE



The Advisory Board Company provided 5,000 volunteer hours to the Austin community over the past year. Examples include:

- Developing an HR strategy plan for Breakthrough Austin,
- Working with the City of Austin on web application platforms to increase community and corporate volunteerism, developing analytical frameworks and care improvement strategies for multiple community health clinics in the region,
- A number of hands-on activities that include "Saturday Service" events and staffing of a weekly Meals on Wheels route and monthly Ronald McDonald House dinner.
